

# MT. PLEASANT TOWNSHIP PARK RULES FOR 2016

## I. BALLFIELD RESERVATION POLICY & RENTAL FEES:

Reservations for Ballfield facilities submitted jointly by Township-Based Leagues (Ft. Cherry Youth Baseball & Ft. Cherry Fast Pitch Softball) through March 31<sup>st</sup> shall be given preference in scheduling. Reservations received by Township residents through March 31<sup>st</sup> shall be given preference to remaining fields/times not reserved by Township-Based Leagues, before reservations for non-resident leagues or individuals are approved. All Reservations made on or after April 1<sup>st</sup> shall be processed in order of application.

<b>Residents &amp; Township Based Leagues:</b>	<b>No Fee.</b>
<b>Non-Residents/Non-Township Based Leagues:</b>	<b>\$50 per Rental (3 hours)</b>

## II. PAVILION RENTAL FEES:    LIONS DEN            LOWER            SOUTHVIEW            WESTLAND

**NOTE:**    Rental fee is due when reservation is made.    **Facilities are to be left in clean condition.**    Policy applicable to refunds as follows for cancellations.

Refreshment building is included to Lower Pavilion renters.

## II. PAVILION DEPOSIT FEE:

A separate \$50.00 refundable deposit fee is required at the time of the pavilion rental. This deposit fee will be returned after the rental, providing park conditions are adhered to and no damages to the pavilion and/or pavilion amenities occur.

## III. PAVILION FACILITIES:

- A. **LIONS DEN** - Accommodates **100 + people**. Equipped with electricity, water, 14 picnic tables, two barbecue grills, adjacent playground equipment, horseshoe pits, volleyball and basketball courts/nets, adjacent restrooms.
- B. **LOWER PAVILION** – Accommodates approx. **50 people**. Equipped with electricity, water. 6 picnic tables, playground equipment and adjacent restrooms. **(the concession stand no longer comes with the lower pavilion rental)**
- C. **SOUTHVIEW PAVILION** - Accommodates **100 + people**. Equipped with electricity, water, 12 picnic tables. adjacent restrooms, basketball and volleyball courts/nets and playground equipment.
- D. **WESTLAND PAVILION** - Accommodates **75 people**. Equipped with electricity, water, 9 picnic tables, adjacent restrooms, and playground equipment.

## IV. CONDITIONS:

1. **NO STAPLES OR TACKS OF ANY KIND PERMITTED ON ANY PICNIC TABLES.**
2. **NO PARKING OR DRIVING ON GRASS**  
**(Food & supply drop off is allowed provided that the ground is DRY and vehicle does not leave ruts in the grass)**
3. **NO** exclusive use of tennis courts or ball field at the Hickory Park or Southview, unless otherwise reserved per the above Ball Field Reservation Policy & Rental Rules.
4. Water & electric will be turned on by the park attendant.
5. Renter’s responsibility to make sure pavilion and grounds are left in **good and clean condition\*** and electricity is turned off. **\* ALL SIGNS, BALLOONS, ETC. ARE TO BE REMOVED.**
6. **ALCOHOL** is restricted to Park Pavilion.
7. Noise must be contained.
8. Park closes at 10:00 P.M. sharp.
9. Bikes and skate boards are not permitted in pavilions or on the tennis court.
10. Vehicles, except those transporting food, elderly or handicapped, are restricted to the parking lots.
11. Rental of pavilions does not assure use of all park facilities, but an effort will be made to keep organized use to a minimum on weekends.
12. **YOU WILL BE BILLED FOR ANY DAMAGES THAT OCCUR DURING YOUR RENTAL.**
